1. That the statements contained herein are based upon Affiant's personal knowledge and that Affiant is competent to testify regarding the matters set forth herein.
2. My name is Matthew Perkins ("Matt"), and I am a resident of Madison County, in the State of Mississippi. I am currently employed by the Mississippi Band of Choctaw Indians d/b/a Choctaw Resort Development Enterprise ("CRDE") as Executive Vice President of Marketing and Hotel Operations.
3. On January 27, 2015, CRDE hired David Ellis Malbrough ("David") as its Director of Planning and Analysis. At times David worked with me to analyze marketing and player activity.
4. David and I became personal friends.
5. David resigned from CRDE. His termination of employment date is October 10, 2019.
6. The Meruelo Group, in Reno, Nevada, hired David. Upon information and belief, his current residence is in Sparks, NV.
7. David received a bachelor's degree in Finance from Louisiana State University.
8. On October 12, 2021, David called me and said that his friend, Gary Brown, wanted to stay at the casino for two nights beginning October 16, 2021, on a complementary basis. The complementary room was booked on October 12, 2021, for arrival on October 16, 2021, and departure on October 18, 2021, and we gave them a hotel reservation for that stay. Mr. Brown did not check into the room.
9. After Brandon A. Sibley and Howard G. Brown filed their Complaint in Case No. 3:22-cv-256-DPJ-FKB against CRDE, I contacted David. He expressed the thought that the fact that Brown and Sibley had filed a lawsuit against CRDE was humorous. Later in the conversation he expressed concern about the suit and informed me that his sister, an attorney, was helping Sibley and Brown with the litigation.
